_MINUTES OF THE MEETING HELD IN THE COMMUNITY CENTRE, LLANELIAN YN RHOS AT 7.30.pm ON MONDAY 1ST NOVEMBER 2021.

- 1. WELCOME The Chairman welcomed everyone to the meeting.
